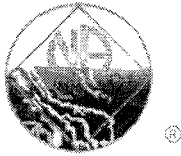

Our interactions with the Board of Directors and each other have been slow and non-existent from time to time we need ideas from you on how to streamline our lines of communications. Communication is a two way street let's get it together and not hamstringing our projects. I'll ask all to pick up the phone or respond to our emails within a reasonable amount of time and not leave servants hanging?

Protecting our name.

I have noticed that more and more of our flyers t-shirts and merchandise has shown the NA logo including the service logo without the registered trademark ® or ™. Although our name and logo belong to us as a fellowship, we as members, groups and service bodies have a responsibility to protect our name and logo. The only way we can maintain legal control over our rights of ownership is to adhere to the Fellowship Intellectual Properties Trust. We only have the right to use the name or logo if it is accompanied by the registered trademark ® or ™. I have attached to my report a copy of bulletin #1 of the FIPT and ask for all Areas to copy it and disburse it to all of your committees and groups. Also please consider including a copy in your area guidelines along with language binding your committees to its use.

Being responsible stewards of NA assets

We had a bad year financially last year. In fact we had to ask our subcommittees to reduce their budgets by 40% and we were not able to meet our commitments to the WSC last year.

Then our committees submitted their budgets for this year. They were in excess of last years budgets, that were in turn 25% higher than our income for our best year.

RCMs, you are the stewards of our 7th tradition funds. When we collect monies, we have a responsibility to follow the 11th concept and make sure we prioritize the proper disbursement of our funds. It is your job to make our committees including the administrative committee and RD team fit within our income, not exceed it.

I personally this year have paid my own gas and my half of the hotel bill for all but one workshop or assembly we've held this year. Although I don't feel everyone should have to do the same. I do believe many of us could do much better with much less than we have become accustomed to.

Regional Assembly

Our Regional Assembly held in Southeast Area was well attended by the local fellowship and South Central, but only a few GSRs showed from East Valley, Phoenix and West Valley, and none from any other areas.

We had great participation from all who attended. Our Regional Chair, Literature Review, Hospitals and Institutions, and Public Relations all reported on the operations of their committees and plans for the coming year.

Each Group in attendance gave a report. Then we had a workshop on the IDT (Issue Discussion Topic) of Group Conscience.

South West Area Trusted Servants Learning Day.

Once again we participated in the TSLD for South West. Our workshops were on, NA 101 Ken F., The New Traditions Book Jim B., PR Basics Greg W., PR "It's all about me" Rosie W., Hospitals & Institutions Basics Patty S., Group Service Basics Jim B. & Ken F. Much fun was had by all and everyone participated. One of the unique features of this TSLD is that it is held in a detox center, this gives the new member direct access to the inner workings of NA and our passion for recovery in a very meaningful way. However it does have its drawbacks. Because we are in a treatment setting, clear limits need to be set with the institution as to our expectations of them and theirs on us. We still need to follow our traditions, we pay our own way, we thank the institution for access, but we do not directly endorse them or their methods. If it is an NA event it needs to be clearly an NA event. Having said that, I do believe this particular learning day format furthers our primary purpose. I have been at this event three years running now, and have seen former clients that attended the TSLD in the previous years there every time. Service is always about the 12th step in action and this event proves it.

Ken and I have been doing Regional Assemblies for awhile now, and one of the things that these assemblies all have in common is, great attendance from the host area, good attendance from neighboring areas, but little to no attendance from outlying areas. We are continuing to explore new ways of getting a clear picture of how the Groups in Arizona think and feel, what we all want, and the best way for all of us to see that picture. A Regional Assembly that every GSR attends is the very best way to get that picture. But try as we might, it just never has happened, and the larger we grow the less likely it seems. This is why we have been pursuing a system of balloting absentee GSRs. This is also why we have been exploring a system of unified Group email addresses, so that we have a reliable single point of accountability. The Regional Assemblies were created to give groups direct access to changes in our literature and our services worldwide. Communication is the core of what they are about. Smaller more Local Service Assemblies may work better for us. After all it seems to be what we're getting anyway. We will continue to explore all options available to us.

I wish to thank all of the committees that helped make these learning days and workshops such a great success.

Internal Use of NA Intellectual Property

NA Intellectual Property Bulletin #1 was approved by the Fellowship of Narcotics Anonymous as given voice by its groups through their regional service representatives at the World Service Conference on 27 April 1993, applicable as of 1 May 1993. It was amended at the World Service Conference in 1997 and 1998. This bulletin supercedes all previous Bulletins and policies pertaining to the use of copyrighted literature and registered trademarks and service marks by NA groups, service boards, and committees.

The Fellowship Intellectual Property Trust (FIPT) describes in detail how NA's name, trademarks, and recovery literature are protected and administered by Narcotics Anonymous World Services, Inc. (NAWS). It covers NA's name, trademarks and recovery literature in all forms, including translations, and all mediums, whether printed, electronic and any other media that may be developed in the future. Additional guidelines, contained in this and the other Intellectual Property Bulletins, for the use of NA's intellectual properties by the fellowship are presented as an adjunct to the FIPT. The guidelines are based partly on legal considerations and partly on the nature of NA. By following these simple steps, the fellowship will help ensure that NA's name, trademarks, and recovery literature will always be available to fulfill our primary purpose.

All matters not specifically addressed by the Intellectual Property Bulletins will be considered under the conditions of the Fellowship Intellectual Property Trust. Any questions or concerns about the Bulletins should be directed to NA's World Service Office.

This Bulletin reflects the policy affecting the use of NA intellectual property within the NA Fellowship. Use of the fellowships trademarks and recovery literature is a commitment to comply with these Guidelines. Usage inconsistent with the Guidelines is improper. Usage disputes are dealt with in Intellectual Property Bulletin #5.

Use by NA groups

These Guidelines outline the appropriate uses of NA logos and recovery literature by NA groups. The Guidelines also lay out criteria a group can use to avoid improper use. A description of the NA group--its nature, function, and role in the NA Fellowship--can be found in current NA service manuals. You are encouraged to review those sections describing groups prior to attempting use of the Guidelines described below.

Use by NA service boards and committees

Service boards and committees created directly or indirectly by NA groups may use NA logos and recovery literature in the ways described in these Guidelines so long as they register with NA World Services.

Use by individual NA members or others

Guidelines, in this or other Intellectual Property Bulletins do not grant individual NA members or those outside NA permission to use NA trademarks or intellectual property. Individual NA members or others who wish to use NA's trademarks or copyrighted recovery literature should write directly to NA World Services.

GUIDELINES FOR USE OF NA TRADEMARKS

Some of the NA Fellowship's registered trademarks are: the name "Narcotics Anonymous," the stylized NA initials, the diamond in a circle, and the original NA group logo, all shown below:

A statement of the NA Fellowship's policy on the reprinting of copyrighted NA recovery literature and the use of registered NA trademarks and service marks by NA groups, service boards, and committees



Guidelines for Use

Use of Narcotics Anonymous trademarks should always reflect the seriousness of our primary purpose and our spiritual foundation of anonymity. The Narcotics Anonymous name or trademarks should not be used by an NA group, service board or committee in any way that would imply legal liability or financial responsibility by or to another part of the fellowship, service structure, or outside enterprise.

Narcotics Anonymous trademarks should not be used in any way that would serve to endorse, finance, promote, or affiliate the NA Fellowship with any outside enterprise.

Narcotics Anonymous trademarks should not be used in conjunction with any law enforcement, political, medical, or religious slogans, themes, or other related materials.

Narcotics Anonymous trademarks should not be used or displayed in such a manner as to possibly offend or disrespect the sensibilities of other organizations, groups or NA as a whole.

Narcotics Anonymous trademarks should not be used in any manner that could draw us into public controversy.

Narcotics Anonymous trademarks should not be used on locally developed recovery literature.

"NA Fellowship Approved" trademark

The "NA Fellowship Approved" trademark is used to indicate that a piece of recovery literature has been approved by the Fellowship of Narcotics Anonymous as given voice by its groups through their regional delegates at the World Service Conference. The "NA Fellowship

Approved" trademark may not be used on any other materials.

Marking trademarks

Either the capital letter "R" or a "TM" should be placed inside a small circle to the right of all NA trademarks every time any of them are used. By doing so, we are showing that these logos are legally owned or registered trademarks. This is one way in which we help preserve the fellowship's legal right to ownership of its trademarks.

Protecting artwork

Whenever an NA group, service board, or committee has an artist create original artwork, drawings, designs, or screens using any NA trademark, the NA body should always be sure the artist signs a document releasing to the NA body his or her rights to the artwork, including the original rendering. By doing so, we ensure that neither the NA logos nor any artwork that has been created for the benefit of the fellowship can later be used to benefit a private individual or an outside business enterprise.

GUIDELINES FOR REPRODUCTION OF NA RECOVERY LITERATURE

NA World Services acts as the publisher of all NA Fellowship-approved recovery literature. As such, it has been entrusted with the responsibility to obtain copyright protection for these items on behalf of the fellowship. This ensures that the fellowship's message as presented in our books and pamphlets is not tampered with.

Narcotics Anonymous World Services is largely dependent on the income generated from the sale of NA recovery literature. This income is used to cover the costs of publishing as well as the expenses associated with other services provided to the World Service Conference and the NA Fellowship-at-large. A large part of NA World Service's income comes from NA groups who purchase recovery literature to distribute at their meetings. Many groups consider their purchase of NA Fellowship-approved recovery literature as one way in which they contribute to the unity and growth of NA as a whole.

Use by NA groups

As a general rule, no one has the authority to reproduce NA Fellowship-approved recovery literature without prior written permission from Narcotics Anonymous World Services. However, given the nature of our fellowship, our experience indicates that NA groups and **only NA groups** should have the authority to reproduce fellowship-approved recovery literature in certain instances. When preparing to reproduce NA Fellowship-approved recovery literature, NA groups should discuss the Fourth Tradition and follow all of these general guidelines:

1. An NA group should only reproduce NA Fellowship-approved recovery literature when it has a clear need to do so.
2. NA Fellowship-approved recovery literature reproduced by an NA group should be distributed only within that group. Such materials should always be given away free of charge; they should never be sold to generate income.
3. The text of NA Fellowship-approved books and pamphlets reproduced by an NA group should not be altered or modified in any way.

Final Goals Area Inventory

11/11/12

There is adequate training & mentoring of ASC members.

Goal: Each home group is encouraged to elect a GSR-Alt who will accompany the GSR to Area meetings; it is recommended that both the GSR and the GSR-Alt positions be a year-long commitment. Our Area already has in place an opportunity for newly elected trusted servants to be mentored during June and July before those positions are assumed in August. Additionally, all ASC trusted servants are encouraged to attend an annual Trusted Servant Learning Day.

There is adequate support for ASC members.

Goal - Improve awareness of the GSR Forum by creating an informational flier and sending it to home groups every 6 months. The information will include the time, location, and purpose of the GSR Forum. Additionally, it will state that this Area uses The Twelve Concepts of NA Service and a modified form of Robert's Rules of Order. The flier will also recommend that the GSR bring and be familiar with The Guide to Local Services and have a GSR-Alt attend the meeting with them for the purpose of mentoring that group's next GSR.

An atmosphere of courtesy and respect is fostered.

Goal: At the start of each ASC meeting and again after the break, the Chair will state the ground rules for participation (ie: when speaking do so with respect, integrity, and patience, not with animosity).

Goal: Adopt Consensus-Based Decision-Making instead of using Robert's Rules of Order. The committee suggests creating one outline along with Guidelines.

Members' concerns are being expressed without fear of reprisal.

Goal - At the start of each ASC meeting, after the Chair states the ground rules for participation, he/she will also read the following:

Narcotics Anonymous is best served when all ideas are welcomed and encouraged. The expression of ideas has the greatest impact when done in an atmosphere of open-mindedness, tolerance and mutual respect. Any effort to stifle the expression of a relevant idea, even those deemed controversial in nature, or to demean the individual offering the idea in any way cannot be tolerated.

Additionally, the Chair will also announce that if any member has a concern, an unanswered question, or needs clarification on the ASC proceedings, that a member of the Executive Committee or an available GSR can meet with that member during the Break or after the ASC meeting to discuss it. These same announcements will be made at the start of the GSR Forum.

A positive sense of unity is evident.

Goal - Change the ASC Guidelines to add a clarifying statement in the section on Sub-Committee Chair's responsibilities, regarding attendance at the ASC meeting being from 3:00pm until after the Break.

Goal - Create a GSR Orientation packet for new GSRs or Alt-GSRs which will explain the duties of the GSR. It will include a description and state the purpose of the GSR Forum, and explain Motions (ie: how to discuss, write, and present Motions).

A sense of willingness for members to participate is encouraged.

Goal - Create a flier for all open positions at Area to increase knowledge, awareness, and the need for someone to step up and serve. The flier will include the purpose and duties of the position.

Goal – Change both the Area Guidelines and each Sub-Committee Guidelines to state that any ASC trusted servant position that has a two-year term comprised of first being the Vice-Chair or Alternate, followed by being the Chair, require the Chair of that Sub-Committee, upon completion of the two-year term, to take a one-year break from being the Vice-Chair or Chair of that Sub-Committee.

ARSC Treasure Report

The October 31, 2012 reconciled balance is \$25,106.70 which is approximately \$22,400.00 more than last year. The current balance in the region's account is \$25,023.59. I have included the September and October Account Summary in this report.

Assuming the subcommittee budgets are approved this month, I will be recommending that region make a \$5,000.00 donation NAWS. I think it would be prudent to increase the prudent reserve for region for several reasons:

1. The region's revenue is not consistent and our expenses do not always match the revenue. We should not donate the additional money received from ARCNA to NAWS. Last year our actual expenses were \$20,728 and our revenue, not including, ARCNA, was \$20,424.
2. The budgeted expense's for this year is \$6,000.00 more than last year. If this is accurate we would need to see an additional \$6,000 in donations over the year and that is unlikely.
3. ARCNA is our largest source of revenue however the amount varies significantly from year to year. Region received \$19,700 for this past ARCNA, \$6,150 in 2011, \$6,805 in 2010 and \$16,178 in 2008.
4. In the lean years it would have been helpful to have additional money in reserve so that the RCMs did not have to donate their mileage reimbursement and we could have funded travel to the WSLD and the Zonal forum.

I have included as an attachment to this report the year to date expenses for each sub-committee.

East Valley Area Report November 18, 2012

Greetings Region Committee, here's what's happening in the East Valley:

Sub-Committee Reports

H&I –The committee submitted Guidelines and a budget, both of which were approved. The H&I member we sent to the WSLD was very excited about the experience, and encourages our Region to host a WSLD in the future.

Blues Fest – The annual Blues Fest was a success. Given that the committee began under by \$1000, due in part to the theft of monies from the previous year's Chair, Rick O. as well as a loss from the March Metal Madness, the mere fact that we came out ahead with a donation is nothing short of a miracle. The event itself took in \$4007, and after expenses, the earlier losses totaling \$1000, a prudent reserve, and money set aside to purchase pop-up shades needed for the next Blues Fest, we were left with \$682 to donate. A full accounting of the monies, as well as an audit will be conducted before our next Area meeting, and I will make those records available to Region in January. We elected a new Blues Fest Chair, Grant E., who the committee recommended for that position. While Grant doesn't have the suggested clean time now, he will have it by March, when we host the 2nd annual March Metal Madness event, on March 24th. Additionally, he has a number of supports in place to help him with the work as well as help him maintain his recovery.

Activities –I brought a number of colored fliers announcing the events coming up for the next two months in the East Valley. Please make sure to pick some up for your Area.

Newsletter – The first newsletter in several years was available this month. The committee submitted Guidelines and a budget, both of which were approved. We passed a Motion to have the committee create a subscriber list so that the newsletter can be sent out to individuals electronically. Members of the fellowship can still purchase a paper copy of the newsletter for \$0.25/copy. Members can turn in their submissions through the Regional website: evasubmit@arizona-na.org. All submissions will need either a one-time or annual release form completed. The committee is looking for clean dates, articles, poetry, cartoons, jokes, etc.

Literature – The Chair for this committee stepped down unexpectedly due to persona stressors. A new Chair has been elected.

Current Open position at Area: Public Relations; Outreach; RCM II; Alt Secretary; Alt Policy & Guidelines; and Alt Treasurer.

Administrative Committee Reports

Chair- The previous year's Blues Fest Chair, who absconded several hundred dollars, has not made any payments in several months, still owing \$253. Our Chair did some research to gather information on a civil suit to get the remaining money. Our Area has followed all the procedures as outlined in our Guidelines under Loss and Recovery. We may have to resort to this last option of taking Rick O. to court. More information will be forthcoming.

Vice-Chair – A meeting flier was brought to our attention, regarding a meeting out at Williams Airfield. No one in the Area knows of a meeting there. She will find out if this meeting exists.

Secretary – Our newly elected Secretary is unaware that our Guidelines state our Minutes are to be submitted to Region. The GSRs have asked me to seek clarity on this topic. Do we delete contact information before sending the Minutes to the webservant? Is there a deadline?

Ad-Hoc Committee

The Area Inventory has been completed. I have included the list of goals (recommendations) that were created as a result of this process. The goals were given to the GSRs to take to their home groups. They were encouraged to decide which, if any, of the goals their home group wanted the Area to implement. The goals included procedural changes to establish an atmosphere of courtesy and respect at the ASC, as well as items that would have to be written as Motions, five of them being Guideline changes.

While an annual inventory (not audit) is recommended in our Guidelines, one had not occurred in three years, and the previous inventory had not included the East Valley fellowship as a whole. This year's inventory has resulted in greater awareness among the leadership and effective cooperation among the members of the ASC. The GSRs were given a Survey in March to get the home group's input on how effective our Area was will be given to the GSRs again in Feb. 2013 as a follow-up. The hope is that the results in 2013 will be markedly better than the very low scores in 2012. If other Areas are interested in the process we used to conduct our Area Inventory, I am happy to be of service, since I was the Chair of that committee.

Treasury – We still need an Atl Treasurer. Since our Area Treasurer mails in our donation and half of the cost of meeting lists for the even months of the year, I have our November donation of \$290.88. Additionally, I have a check for \$93.75 for the second half of the cost for the November meeting lists.



Regional H&I Chair Report Regional Assembly October 2012

Introduction:

I wanted to start and let you know I'm sorry I can't be here today as I'm in Denver at WSLD learning and sharing.

First of all thank you for giving me the opportunity to serve as the ARSC H&I chair. I got involved in NA service work very early in my recovery. Service work has been one of the necessary key ingredients in my recovery.

It's the service work that fulfills our primary purpose :
Carrying the message to the still sick and suffering addict.
The amazing part is that its something we have and when we give it away it keeps giving back.

I have grown up in recovery participating in H& I service by chairing meetings, holding different positions on the sub - committee and now serving as your regional Chair.

In the next few paragraphs I will be sharing about communication, experience, growth, knowledge, attraction and

finance. Each of these words will be related to my goals ,dreams, action and budget concerns.

Communication:

Arizona is one of the fastest growing states in our country. NA has also grown at a rapid rate over the years of existence. In order to be consistent and facilitate the state with needed meetings and literature good

communication must be employed.

I was elected in September and am attempting to gather all of my H&I subcommittee chairs contacts information. I want to open the lines of direct communication with all areas of NA.

I will utilize our website, emails, reporting of events, telephone and travel to visit with sub-committees.

I will be compiling a list of all facilities, dates and times where an H&I meeting is being held statewide.

This will allow us to help where any needs and or concerns arise but also give other chairs the way in which to go for help with conducting their meetings, training aids, suggestions guidelines, meeting formats ideas etc.

Experience Knowledge:

Serving as the H&I chair and holding other service positions I have be able to learn and gain knowledge. I have utilized the written guidelines, asked our predecessors for help, worked with fellow members learning concensus based decision making, prayed with my higher power for guidance. All of the these have aided in the ability to help the Phoenix area grow over 25% in H&I standing meetings and 82% in sub- committee attendance and participation.

We learn from experience and I can take what I have learned and openly share the documentation, the knowledge, the Do's and Don'ts and past experience to help other areas build a stronger foundation and experience new growth. Growth meaning more volunteers and more facilities to host meetings.

The end result being more clean addicts in recovery continuing carrying the message.

Attraction/ Participation :

After building a strong foundation and recruiting new members we have to get them involved immediately. Teaching them to be accountable to their meetings, showing up and reporting to the subcommittee. These tasks builds integrity and solidify our reputation within the recovery arena.

Following the guidelines and being open minded to new suggestions creates a fellowship based foundation .

Discipline or corrective measures also arise and sometimes voting or hard decisions have to to be made and followed to maintain the structure the fellowship created.

These processes come directly from the loving heart for helping others and combining that love with structure, accountability, guidelines create a growth effect that everyone wants to participate in.

It's the "I want to be a part of that" effect.

Goals:

One of the goals I have for the next year is to host interactive workshops. I will be submitting a program idea to the ARCNA program chair after this next WSLD.

Several people in various sub-committes have expressed an interest to participate in putting one of these on at ARCNA 2013.

Some of the topics provided at the workshops will be how to carry the message into different types of facilities, how to be an effective chair, reaching out to our communities, how to grow your committees, and hosting a successful TSLD.

We intend these workshops to be hands on participation, writing, sharing and solving case studies in a small group environment.

Another goal is overall growth of the fellowship and at the H&I level of participation and meetings handled throughout the state.

The building and maintenance of the NA reputation within the recovery community.

Several other goals were mentioned earlier in this report such as foundation building and opening the lines of communication.

I also would like to start working a lot closer with the PR committee as I feel that we have similar goals and the need for support can come from each other.

Budget :

The way our lives have been shaped are the direct result of the work NA has put into us and what we have chosen to do with it and give back.

That brings me to the bottom line... Budget/Money.

First we must be accountable to the fellowship for the use of its funds. I created an easy form to show what

I selected you by watching your involvement and dedication to the fellowship. With the creative passion you have for life itself I knew you could handle this for me.


I don't know what the year will hold and what outcome will be the result. I can tell you that I'm going to due the best job I can do with fellowship and Gods help.

Dear ARSC of NA,

- We held our **Regional PR subcommittee Nov 18 2012** prior to Region. In attendance were the ARSC Chair, new PR Chair from Phoenix, and Linda from South Central filling in for Deborah, who is ill (sadly), and our PR member and ambassador about the state, Gregg W.
- Scott K our Vice Chair was unable to attend due to his wedding anniversary. Congrats on your wedding anniversary Scott!
- We discussed the three events that PR took part on during the two month (more below.)
- We discussed the new Phoenix Chair's transition and filled him in on past Phoenix PR efforts. He has met with Gregg, and received materials from the past chair. Gregg will help Bretton to get acquainted with the new West Valley Chair.
- We discussed libraries and how to get books into them; along with proper usage of Basic Texts and IWH&W for PR carrying the messages.

Art of Recovery

- Art of Recovery was held on Sept 22, 2012 and was the usual success. Thanks to Gregg W for setting up and staffing the booth, Ken F for helping staff the booth most the day, and to South Central for their vibrant and enthusiastic attendance and support.
- Although your regional PR chair forgot the meeting lists and had to drive back home for them, we did collect over 20 emails and phone numbers for various requests for information. We talked to many professionals, professionals in training, family members, addicts in recovery, and potential NA members throughout the day.

Tucson Assembly

PR attended the Regional Assembly held in Tucson. I presented the state of PR in the Arizona Region along with a truncated version of PR basics aimed at the sophisticated audience of dedicated Trusted Servants who were attending. I also was privileged to read the H&I Chair's report to the body. What a great group of Trusted Servants attended and I had a lot of good conversations with various members about PR and other service related topics.

Yuma TSLD

This was my second attendance at the Yuma TSLD. This event is held in a treatment center called Crossroads Mission. Last year we had a mix of Yuma NA members plus the treatment center folks, but this year we had ONLY treatment center folks in attendance in one of our PR workshops and in the other, we had only 2 community members present.

At today's PR Region subcommittee meeting, we discussed the type of message to be carried to the newcomers and how different that is then than a typical TSLD type training. It was our thought during the PR subcommittee meeting that this event might be better served by making it an H&I meeting. As an individual I love carrying the message to the newcomer and am glad to speak to H&I meetings any time asked.

As PR subcommittee chair I would rather if I drive down to an Area to help them grow their PR efforts to meet with even one or two individuals or a small group so we can focus the information provided on specific PR issues within that NA Area. If there is a TSLD that is held in a treatment center and most attendance is members of that facility, we may want to consider changing our material for the audience, and having a separate set of meetings to help the local subcommittees.

Also we had the Mission broadcast its Christian music during the event. I have been attempting to contact the Yuma NA folks about this, and suggest that we ensure that we make sure we pay rent for the event and that we then can make sure we ask the facility to respect our traditions, as NA is a spiritual not religious program.

PR is not the NA cops. That is another subcommittee. We are just passing an observation along to the Areas to think about. When you use a facility to host an event, please consider PR guidelines along the lines of the 12 Traditions, as if you don't, not only can it confuse the newcomers, but it can also hurt NA as a whole in ways that may not be foreseen at the time.

PR Ad Hoc Website

- We made inch-by-inch progress on the PR Ad Hoc Website during this period. We got a slideshow working in a separate sandbox site and are preparing to update our NA material for that. Our history content person found some history materials for the site and we are going to scan them in and continue our work. Thanks to Bethany H. and Robin R. for all their hard work on this subcommittee!
- We are looking for history information about the Arizona NA Region and how our meetings have penetrated into the Region to carry the message. If you do have some materials or information about Arizona NA history, please contact the subcommittee.

PR Guidelines

To my knowledge, our PR Guidelines, which we approved as a working draft in July, have not yet been reviewed or approved by the Region. This is not an emergency, but it would be nice to have feedback if there are any things the RCMs or other Trusted Servants have noted to change in your guidelines. I have had a little feedback from the RD and from my subcommittee but that's about it.

- **Also during the last period:**
 - News from around the state:
 - Before the Tucson Regional Assembly, I talked to the PR Chairs who I had information from and that is in my presentation. It was requested that I get that presentation put on the Regional website, but I still have some photos from Art of Recovery and state Recovery events, and so I will take identifying information out before I send it in.
 - Last week, Robert S called me for a presentation in West Valley. I was unable to return his calls because of many events going on, but I wouldn't have been able to answer his question anyway, as I still do not have contact information for the

West Valley chair. That highlights the importance for the RCMs or anyone else who knows, please send contact information for your newly elected PR Chairs to Region in some way. It doesn't have to be to me specifically, but often I am called for contact information, and I love to help these events happen in any way I can.

- I have had some conversations with Marcy P. about her plans for the year and her budget. I guess someone in Tucson wanted to know if Region could help out with Area PR efforts. In general, we expect that Areas are looking at their income and needs and keeping in their Area all monies they need to cover the efforts locally, which they are more familiar with. If we reverse this model, then we flow funds downward to Region and Region becomes the big boss of Area efforts instead of the groups, so I do not recommend changing this model. However if the RCMs directs the PR subcommittee to budget monies to help areas, I am sure I and any other PR Chair would be glad to follow the RCMs' direction.

Expenses:
